
SAFETY CONCEPT FOR THE DOLDER GRAND SPA


The following safety measures supplement the existing infection prevention measures set out by the Swiss Confederation.

FACE MASKS

- Face masks must be worn in all publicly accessible rooms and facilities. Within the spa area, all guests must wear masks in reception, in the cloakroom, throughout the treatment area and during any treatments (except facials).
- You can decide for yourself whether to wear a mask in other areas of the Spa.
- All our employees will wear masks except on the spa terrace or during outdoor and indoor group fitness courses.

CAPACITY-RELATED MEASURES

- The maximum number of guests permitted in each area is clearly marked. We would ask you to behave responsibly by not entering these areas if they are already at maximum capacity.
- We kindly ask you to maintain 1.5 metres from our employees and other guests.
- There are no capacity restrictions in the workout area and no requirement to maintain a required minimum distance of 1.5 meters.
- The check-in system in the Spa Front Office will monitor the maximum capacity of the spa area and whether this capacity has been reached.

HYGIENE MEASURES

- All contact areas and surfaces will be disinfected every two hours, or after each treatment. These surfaces include metal door handles, shower and toilet doors, benches, buttons inside and outside lifts, and shower and solarium areas.
- Please disinfect your hands at the reception desk, in the cloakroom or in the fitness area. If you are not already wearing a face mask, please take one from the box at the Spa Front Office and wear it in the specified areas.
- You must always wear your face mask during your treatment. The therapist will also wear their mask throughout the treatment and disinfect their hands before and after.
- After each treatment, the facial recess of the massage bed will be disinfected with a new cleansing wipe and disinfectant, and the towel covering the massage bed will be changed.
- During your workout, please use the wet wipes provided to disinfect the gym equipment after each use. For group fitness and personal training classes, the trainer will clean smaller items after each training session.
- Rubbish bins with lids are provided in all areas of the facility.

GENERAL

- The mask requirement, the distancing rule and the capacity restrictions are lifted in the entire fitness area (including personal training and group fitness courses). For indoor sports, we only need your contact details. Therefore, please register at the Spa Front Office if you wish to take part in our Group Fitness courses.
- Please avoid gathering in the check-in area (Spa Front Office) if possible and adhere to the distancing rule (1.5 meters).
- Only healthy employees are allowed to come to work. We therefore ask that our guests visit us only if they are completely healthy.
