SAFETY CONCEPT AT THE DOLDER GRAND SPA

The following safety measures supplement the existing infection prevention measures set out by the federal government.

Federal Council extends COVID certificate requirement 08.09.2021

From **13 September**, a COVID certificate will be required in the following situations (from the age of 16):

Indoor hospitality venues

- Restaurants and bars
- Clubs and discos

Cultural, sporting and leisure activities indoors

- Museums and libraries
- Leisure facilities
- Zoos
- Casinos
- Fitness centres and sports facilities
- Training sessions*
- Indoor pools and water parks
- Music and theatre rehearsals*

Indoor events*

- Theatre and cinema
- Sporting events
- Concerts
- Private events outside the home (e.g. weddings)

Large-scale outdoor events

- Events attended by over 1000 people

***Exceptions:** Rehearsals and training sessions in fixed groups (max. 30 people), religious services, political events and self-help groups (max. 50 people).

Workplace: Employers may - under certain circumstances and after consultation with employees - incorporate the certificate into their protection plans.

Universities: The cantons and universities may decide on a certificate requirement.

The COVID certificate is available to anyone who is either **vaccinated**, **recovered from COVID** or who has **tested negative**. The certificate can be presented using the app or on paper.

This list is by way of example and not exhaustive. Refer to the COVID-19 Special Situation Ordinance for specific details.

CERTIFICATE REQUIREMENT

- All guests are now only permitted to visit the Dolder Grand Spa with a valid digital COVID-19 certificate from the EU (vaccinated, recovered or tested negative). This applies to all hotel guests, as well as visitors to the spa, restaurant and events.
- The certificate (Switzerland or EU) documents that an individual has been vaccinated against COVID-19, has recovered from the disease or has been tested negative. The certificate can be presented in an app, or in paper form.
- Staff will be available every day between 6.00 am and 12.00 midnight at the entrance in the Golf Wing and at the main entrance to check and scan the certificates.

MASKS

- Masks are no longer required. All other FOPH measures and internal safety concepts continue to apply. Masks no longer need to be worn in any part of the Dolder Grand Spa. Spa guests are free to decide for themselves whether to wear a mask.
- Masks are compulsory for all staff throughout the building.

HYGIENE MEASURES

- All contact areas and surfaces will be disinfected every two hours, or after each treatment. These surfaces include metal door handles, shower and toilet doors, benches, buttons inside and outside lifts, and shower and solarium areas.
- Please disinfect your hands at the reception desk or in the cloakroom.
- After each treatment, the face hole in the massage bed will be disinfected with a new cleansing wipe and disinfectant, and the towel covering the massage bed will be changed.
- Please use the wipes provided to disinfect the gym equipment after each use. For group fitness and personal training classes, the trainer will clean smaller items after each training session.
- Rubbish bins with lids are provided in all areas of the facility.

GENERAL

- Mask requirements, social distancing and capacity restrictions have been lifted in the entire spa area due to the certificate requirement. As contact details still need to be recorded for indoor sports activities, please register for group fitness courses at the Spa Front Office.
- Only healthy employees are allowed to come to work. We therefore ask that you visit us only if you are completely healthy.
